 a Herd District } ORDER CREATING HERD DISTRICT

This matter came on for hearing before the Board of County Commissioners for Bonner County, Idaho on the 6th day of October, 1975 on the petition filed pursuant to Idaho Code 25-2404 requesting the creation of a herd district in order to prevent all species of the following animals from running at large, to-wit: cows, calf, ox, steer, bull, hog, pig, goat, kid, sheep or lamb, and prohibiting any animals heretofore mentioned from being herded upon public highways in such district, the boundaries of said proposed herd district being generally described as being the present boundaries of the following described property, situate in the County of Bonner, State of Idaho, to-wit:

-----Commencing at the north quarter corner of Section 7,  
 Township 56 North, Range 5, west of Boise Meridian;  
 thence South, 3960 feet;  
 thence East approximately 1070 feet to the west side  
 of now existing road;  
 thence southwesterly along the west side of the now  
 existing road, to the south line of Section 7;  
 thence continuing along the west side of the now  
 existing road to the north-south center line of Section 18;  
 thence south along the north-south center line to the  
 southeast corner of the northeast quarter of the northwest  
 quarter;  
 thence West, 2640 feet to the west line of Section 18;  
 thence north to the southeast corner of Section 12,  
 Township 56 North, Range 6 West;  
 thence West to the Washington-Idaho line;  
 thence North to the east-west center line of Section 1,  
 Township 56 North, Range 6 West;  
 thence East to the east line of Section 1;  
 thence North to the northwest corner of Gov't Lot 8 in  
 Section 6, Township 56 North, Range 5 West;  
 thence East to the northeast corner of Lot 8;  
 thence North to the northwest corner of Gov't Lot 3;  
 thence East to the northeast corner of Gov't Lot 3;  
 thence South to the center of Section 6;  
 thence West to the northeast corner of Gov't Lot 9;  
 thence South to the southeast corner of Gov't Lot 9;  
 thence West to the Section line;  
 thence South to the southwest corner of Section 6;  
 thence East to the point of beginning; - - -  
 LESS Full Moon Lode in Section 6, Township 56 North, Range 5,  
 West of Boise Meridian.-----

NOW, THEREFORE, it is the finding of this Board that a majority of the landowners owning more than fifty percent of the land in the proposed herd district, who are residents in and qualified electors of the State of Idaho, favor creation of the said herd district; and that it is beneficial to create the proposed herd district, and in consideration thereof

IT IS HEREBY ORDERED That a herd district be, and it is, created within the present boundaries of the above real property effective as of December 1, 1975.
